1. **Beldandi rural municipality has allocated funds** towards the cost of **Procurement of Construction of RCC road from Shivnagar bridge to Khairighat Chaurah to Balram tole ,ward no.03, Beldandi Kanchanpur** and intends to apply part of the funds to cover eligible payments under the Contract for **Procurement of Construction of RCC road from Shivnagar bridge to Khairighat Chaurah to Balram tole ,ward no.03, Beldandi Kanchanpur. BRM/2080/81/Works/NCB-01.** Bidding is open to all eligible bidders as per Section V of bidding document.
2. **Beldandi rural municipality ,Office of the rural municipal executive,Beldandi,Kanchanpur** invites electronic bids from eligible bidders for the construction of **RCC road from Shivnagar bridge to Khairighat Chaurah to Balram tole ,ward no.03,Beldandi Kanchanpur** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures . Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 3,49,21,660.00**
  - Minimum Work experience of similar size and nature: **at least One (1) Contract within the last ten (10) years, with a value of at least NRs. 93,12,442.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Electronic bids must be submitted to the office **Beldandi Rural Municipality, Office of the rural municipal executive, Beldandi Kanchanpur** through PPMO 's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 pm on 2080/07/10. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2080/07/10 at the office of **[Beldandi rural Municipality, Office of the rural municipal executive, Beldandi Kanchanpur]**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 6,75,000.00 which shall be valid for 30 days beyond the validity period of the bid i.e. Feb 22 2024.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
